# ORDINANCE NO. 2019-01 RIVER FOREST TOWNSHIP COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE FOR 2019-2020

Of the TOWN OR RIVER FOREST in the County of Cook, State of Illinois, for the fiscal year beginning April 1, 2019 and ending March 31, 2020.

WHEREAS, all legal requirements have been complied with:

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TOWN TRUSTEES OF THE TOWN OR RIVER FOREST, COOK COUNTY, ILLINOIS, in meeting assembled as follows:
